I agree to actively participate in a CHeCS accredited Johnes testing scheme and have results available at least 10 working days before the sale date. I understand that the progeny of ELISA positive Dams including surrogate dams in the case of embryo animals are ineligible for entry to the sale unless their status has been resolved by a Negative result to either Johnes Faecal Culture or Johnes Faecal PCR. I agree to furnish the Irish Limousin Cattle Society with a Veterinary Bull Fertility Examination health certificate at the sale.

The use of narcotics, pain suppressants and sedatives on animals selling in official Limousin Society sales is absolutely forbidden – checks for same. Having signed this form as above, it is assumed you will permit random testing of your animal as the Chief Steward directs.

Blue Card, Pedigree Certificate, Veterinary Bull Fertility Examination health certificate must be furnished to steward at pre-sale inspections.

NOTE: If emailing or faxing sale entry forms to Society Office it is your responsibility to call the office to ensure they have been received. The Society will not take responsibility if this is not adhered to.

# **Regulations for Entry to Society Sales**

- 1. Males must be between 13-24 months of age for autumn sales and 14-24 months for spring sales.
- 2. Females must be over 12 months of age (unless a special Heifer Calf category is included in the sale).
- 3. Males must weigh 570kgs or more at sale inspection time for all society sales
- 4. If 1.7kg average daily weight gain is exceeded by a bull (1.5kg for a heifer) and he/she has not been verified at birth, entry to sale will not be allowed
- 5. Animals must be in vendors herd for a minimum of 6 CONSECUTIVE months prior to sale
- 6. All Animals must be Genomically Tested.
- 7. Herds consigning cattle must be actively participating in a CHeCS accredited Johnes herd testing programme and have results available at least 10 working days before the sale date. This means all animals in the herd that are 24 months and over, whether pedigree Limousin or otherwise, are to be tested annually in accordance with the rules of CHeCS.

**Note:** the onus is on you, the herd owner, to ensure all information is up-to-date in advance of the sale day. If a female is under 2 years of age at time of annual Johnes test but subsequently turns 2 years of age by the time of a Society sale you will be required to test this animal for Johnes before your annual Johnes test.

- 8. All animals entered for sale must have tested negative for the BVD Virus once within their lifetime. BVD declaration forms are required for animals born before 2013
- 9. All bulls will be sold under a **Bull Fertility Scheme** in conjunction with FBD Insurance Ltd. This scheme is mandatory and the premium is paid by the seller.
  - Bulls must undergo a 'Veterinary Bull Fertility Examination' and an evaluation of mouth and eyes. This must be conducted by an approved vet who will provide the breeder with a recognized health certificate to be presented to Society officials at the relevant sale. A list of approved vets is available on the Society website. This Examination is valid for 60 days.
- 10. All animals must have a valid pedigree certificate at time of submitting entry form to sale
- 11. Use of narcotics or pain suppressants is strictly forbidden at Society sales
- 12. Random checks for sedatives, growth promoters and DNA will be carried out at the sale
- 13. White coats must be worn during the show
- 14. All bulls have a ring in their nose. Iron halters are forbidden at Society sales.
- 15. Any animal with a white spot larger than a 1-euro coin should not be entered at a Society Sale and will be rejected at time of inspection.

#### Additional Regulations for Entry to Premier Sales

- 1. All animals must be export tested
- 2. Minimal weight for age applies for Males in Premier Sales details available from the Limousin website, www.irishlimousin.com
- 3. Animals entered must satisfy the 1.7kg Rule, have an ADG of less than 1.7kgs/day (1.5 kg for females) from birth to linear scoring & weighing subject to verification (allowing 45kgs birthweight)
- 4. Animals must enter the Sale Centre the evening/night before the sale
